

**Title** SC000025964: Registering for the Holiday Activities and Food Programme

For this summer, children entitled to benefit-related free school meals (FSM) will need to register with the council ahead of booking with one of the many providers delivering schemes.

We are currently encouraging all schools to forward the linked parent / carer letter just to families of those children entitled to benefit-related FSM so they can register for their unique booking code in good time.

After the half-term break, we will be sending you information about the 150+ schemes we will have running across the county this summer that have funded places that mean those children can access fun activities and a meal for free.

Schools can register on a family's behalf, where additional support is needed, using the same form.

The registration process allows the HAF Team to ensure that funded places go to only those eligible for the programme. If we are unable to confirm a child's eligibility, we may contact their school to help clarify their status and would appreciate your support, if required.
